

**1. Name of Work**

Installation of Sprinkler Points in Block A, B & C of **Mahavir Cancer Sansthan, Patna.**

**2. Scope of Work**

Supply, installation, testing, and commissioning of sprinkler points to be installed on each of the six floors, in rooms, and in all other required areas wherever necessary, including connection to the existing down-comer system, ensuring guaranteed performance parameters.

**3. Time Allowed for Completion**

03 (Three) calendar months from the date of Issuance of the Letter of Intent (LOI) / Work Order. In case of any delay in completion of the work, the vendor shall provide prior intimation along with the revised expected date of completion.

**4. Price Basis**

Prices shall be firm and inclusive of all duties and taxes. GST shall be paid extra as applicable. No escalation shall be permitted except for statutory variations on items listed in the Schedule of Quantities

**5. Earnest Money Deposit (EMD)**

The rates quoted by the bidders shall remain firm throughout the contract period (including any authorized extension). The rates shall be inclusive of all duties, levies, royalties, and other incidental or industrial charges. GST, as applicable, shall be paid extra by the Bank as per actuals.

#### 18. Terms of Payment (Stage Payments)

##### a) On Supply & Delivery at Site:

50% of the contract value will be paid upon receipt of the preforma invoice, subject to verification by the Sr. Engineer & Fire Officer, Fire Safety (Engineering Department) of Mahavir Cancer Sansthan, Patna.

##### b) On Testing & Commissioning:

45% of the contract value will be paid within thirty (30) days after successful testing and commissioning, jointly carried out by the vendor's team and the Sr. Engineer & Fire Officer, Fire Safety (Engineering Department) of Mahavir Cancer Sansthan, Patna.

##### c) Balance Payment:

The remaining 5% will be released after 3 months.

#### Note:

a) Final payment will be made based on the actual material used at site and the actual work executed.

b) The awarded vendor shall prepare the necessary drawings/designs as per the actual site conditions and obtain approval of the final BOQ before supplying the materials.

c) Necessary test certificates must be provided along with the materials, wherever applicable.

### a) Technical Bid:

The price bid shall be submitted in a separate sealed envelope and will be opened on the date and time stipulated in the tender.

### c) Reverse Bidding:

After the declaration of the indicative price bid, the base price will be decided by the Tender Committee, and a reverse bidding process shall be carried out.

### 23. SECURITY DEPOSIT

a) On acceptance of the Bid, the Bidder shall deposit equal of 2% of contract value (i.e., order value excluding taxes) an Initial Security Deposit to **Mahavir Cancer Sansthan, Patna**. The deposit may be submitted in any of the following forms:

- I. Bank Draft drawn In favour of **Mahavir Cancer Sansthan, Patna**, payable at Patna; or
- II. Bank Guarantee executed by any Nationalized/Scheduled Bank as per the proforma enclosed.

b) If the Bidder fails to provide the Security Deposit within the specified period, it shall constitute a breach of Contract, and **Mahavir Cancer Sansthan, Patna** shall be entitled to award the work to another party at the Bidder's risk and cost. In such a case, the EMD of the awarded Bidder shall be forfeited.

c) No interest shall be payable on the Security Deposit.

d) The Security Deposit/Retention Money shall remain at the disposal of **Mahavir Cancer Sansthan, Patna** as security for satisfactory execution and completion of the work.

**Mahavir Cancer Sansthan, Patna** may deduct and appropriate from the Security Deposit/Retention Money any damages (liquidated or otherwise), dues, or recoveries from the Bidder under this Contract.

e) Upon due and satisfactory performance of all contractual obligations by the Bidder, including completion of work and compliance during the Defect Liability Period, the Security Deposit shall be released by **Mahavir Cancer Sansthan, Patna**, subject to any recoveries, deductions, or retentions as provided under the Contract.

### 24. Documents:

Bidders are required to submit **PAN, GST Registration and MSME** details along with the **Technical Bid of their offer**.

### 25. TENDER SUBMISSION

The tender shall be submitted **by hand, registered post, or courier**.

a) The Intending bidders shall be deemed to have visited the site and familiarized themselves thoroughly with the prevailing site conditions before submitting the tender.

**Non-familiarity with site conditions will not be considered a reason for extra claims or for failure to carry out the work in strict conformity with the drawings, specifications, and time schedule.**

- b) If any of the documents submitted by the bidders are found to be false, fabricated, or bogus, the bidder shall be liable for **rejection and/or de-listing**.
- c) Bidders are required to track any **Corrigendum/Amendment** issued by the Tender Inviting Authority from time to time. No separate newspaper advertisement will be published for such updates. The **Mahavir Cancer Sansthan, Patna** shall not be responsible for any claims or issues arising from non-compliance.
- d) Bidders must complete all processes and steps required for bid submission. A bid shall be considered successfully submitted **only after acknowledgement is provided by the system** through a bid submission number upon completion of all required steps.

## **26. SUPPLY OF MATERIAL**

- a) All materials required for the work shall be supplied by the Vendor. In addition, all materials required for temporary and enabling works shall be arranged and provided by the Vendor. All incidental expenses, including loading, unloading, transportation, and handling, shall be the responsibility of the Vendor.
- b) All other materials required to complete the work in accordance with the contract shall be **inclusive of freight, taxes, duties, loading, unloading, transportation, handling, and storage charges**. GST shall be paid extra, as applicable.

## **27. SITE INSPECTION**

The intending bidders shall be deemed to have **visited the site and familiarized themselves thoroughly with the site conditions** before submitting the tender. **Non-familiarity with the site shall not be accepted as a reason for extra claims or for not carrying out the work in strict accordance with the drawings and specifications.**

## **28. INSTALLATION, TESTING, COMMISSIONING & TRAINING**

The **installation, testing, and commissioning** of the automatic sprinkler system shall be carried out by competent engineers/technicians of the Bidder at the work site. Upon commissioning, the Bidder's engineer/technician shall provide necessary **training to Mahavir Cancer Sansthan, Patna personnel** in the operation and maintenance of the installed fire protection system. **No separate charges** shall be payable by **Mahavir Cancer Sansthan, Patna** for this training.

## 29. INSPECTION AND QUALITY CHECKS

The **Mahavir Cancer Sansthan, Patna, or its authorized representative, or a third-party inspection agency** shall have the right to carry out inspections during the execution of the work. These inspections are intended to verify the **quality of materials, workmanship, and adherence to specifications** as specified in the contract.

### Key points regarding inspection:

Verification of all materials supplied by the Bidder.

Checking the workmanship and quality of installation.

Ensuring compliance with technical specifications, drawings, and safety standards

The Bidder shall be responsible for **rectifying such deficiencies** at no additional cost, within the time frame specified by **Mahavir Cancer Sansthan, Patna**.

**Mahavir Cancer Sansthan, Patna** reserves the right to **withhold payments or take other actions** if the quality of work is not found satisfactory.

Third-Party Inspection shall be carried out if required.

## 30. RIGHT TO ACCEPT OR REJECT TENDER

**Mahavir Cancer Sansthan, Patna** reserves the right to **accept or reject any or all tenders** without assigning any reason whatsoever, or to **negotiate with bidders** in a manner it considers suitable. In case the **lowest price** is received from more than one bidder, fresh price bids shall be invited from these lowest bidders only to determine the final lowest bidder for placement of the order. The work may also be **split among bidders** at any stage, if considered expedient.

Bids of any bidder may be rejected if a **conflict of interest** between the bidder and **Mahavir Cancer Sansthan, Patna** is detected at any stage.

All bids will be evaluated based on the **criteria specified in this tender document**.

Tenders of bidders who do not meet the prescribed criteria will **not be considered for commercial evaluation**.

Tenders submitted through **e-mail or fax** shall be summarily rejected.
